NEWS OF INTEREST TO CHRISTIANS

□ COURT BLOCKS BIDEN RULE THAT WOULD FORCE CHRISTIAN DOCTORS TO PERFORM **GENDER-AFFIRMING SURGERIES** - The following is excerpted from "Major Victory," Christian Headlines, Aug. 30,

"A federal appeals court delivered a major victory to religious liberty advocates Friday by ruling that the Biden administration cannot force religious doctors and hospitals to perform abortions and gender-affirming procedures under Obamacare. The issue was the much-debated 'Section 1557' of the 2010 Affordable Care Act (Obamacare), which prohibits discrimination on the basis of race, color, national origin, sex, age, and disability by medical professionals. The Biden Department of Health and Human Services (HHS)--like that of the Obama the gospels, with the final levels being crucified and then rising administration--interprets Section 1557 to also prohibit discrimination on the basis of sexual orientation and gender identity. Further, Biden's HHS says discrimination on the basis of sex encompasses 'pregnancy termination'--that is, abortion. But the U.S. Fifth Circuit Court of Appeals on Friday sided with a coalition of religious groups, including the Christian Medical and Dental Associations (CMDA) and the Franciscan Alliance. The case is Franciscan Alliance v. Becerra. The appeals court, in a 3-0 decision, affirmed a lower court decision that had permanently blocked the Biden rule. The case dates back to 2016 and has seen multiple stages, with the Trump administration dropping the Obama rule. The Biden administration then mostly reinstated the Obama rule. The judges noted that the Biden rule would 'require that hospitals perform gender-reassignment surgeries and abortions.' Critics have dubbed the rule the 'transgender mandate.'...'This ruling is a major victory for conscience rights and compassionate medical care in America,' said Joseph Davis, an attorney at Becket [the legal organization that battled the Biden rule in court]. 'Doctors cannot do their jobs and comply with the Hippocratic Oath if the government requires them to perform harmful, irreversible procedures against their conscience and medical expertise."

□ PEPPA PIG GOES GAY: INTRODUCES SAME-SEX POLAR BEAR COUPLE - In an episode broadcast on Channel 5 Tuesday (6 September), Peppa is joined by classmates Suzy Sheep, Danny Dog and Penny Polar Bear as they start drawing pictures of their family. Penny draws two female Polar Bears in dresses before turning to Peppa and saying: "I'm Penny Polar Bear. I live with my mummy and my other mummy. One mummy is a doctor and one mummy cooks spaghetti. I love spaghetti."

The show has been running since 2004, but this is the first time in its 18-year history it has featured a same-sex couple.

The move comes two years on from a petition demanding a "same-sex parent family on Peppa Pig". The petition, which has now gained more than 23,000 signatures, stated: "Children watching Peppa Pig are at an impressionable age, and excluding same-sex families will teach them that only families with either a single parent or two parents of different sexes are normal.

"This means that children of same-sex parents may feel alienated by Peppa Pig, and that other children may be more likely to bully them, simply through ignorance."

Peppa Pig's new characters come three years after Mr Ratburn got married to a man in the long-running animated series Arthur, which went viral for paving the way for LGBTQ+ inclusivity in children's TV.

Previously, Peppa Pig has shown its LGBTQ+ vibes, releasing queer anthem "Rainbow, Rainbow" in the show's first

□ JESUS CHRIST SIMULATOR? NEW VIDEO GAME ALLOWS PEOPLE TO PLAY THROUGH THE GOSPELS AS THE MESSIAH - A Christian video game designer has created a virtual reality game that allows players to play as Jesus through from the dead. The promo material for the game 'I am Jesus Christ' explains:

"Walk in the footsteps of Jesus in this incredible first-person retelling of the story of Christ from birth to resurrection. Perform amazing miracles, interact with a cast of biblical figures and travel around the Holy Land from Jerusalem to Galilee. Become the Messiah in 'I Am Jesus Christ."

The game is the brainchild of Maksym Vysochansky, who created it for SimulaM games. In an interview with Premier Christian News, he explains that he hopes kids "will use this game to learn more about who Jesus Christ is."

□ NEW DISNEY CARTOON SERIES DOMESTICATES **DEMONS** - Disney-owned FX is releasing a new adult cartoon series, "Little Demon," about a woman who has a fling with Satan (voiced by popular actor Danny DeVito) and bears his child. According to the show's description, "Thirteen years after being impregnated by Satan, a reluctant mother, Laura, and her Antichrist daughter, Chrissy, attempt to live an ordinary life in Delaware but are constantly thwarted by monstrous forces, including Satan, who yearns for custody of his daughter's soul." As an TV-MA cartoon in the vein of "South Park" and "Family Guy," "Little Demon" takes it a step further with Satanic symbols, witchcraft, demonic activity, nudity, and violence.

With the animation coming soon to Disney+, Star+, and Hulu, the parents of Disney's primary audience are not happy about this release. One Christian parents' activism group, One Million Moms, has garnered over 20,000 signatures petitioning Disney to cancel the series. "We must do so because Disney is introducing viewers, including children who might stumble across this series, to a world of demons, witches, and sorcery. Along with the demonic content of this series, the minds of younger viewers will also be inundated with secular worldviews that reflect the current culture."

This horror-comedy is yet another reason many parents are raising alarms about Disney. A number of recent actions by the media conglomerate have caused controversy among parents as Disney continues targeting children and families with their content.
